When process is due In its early decisions, the Supreme Court seemed to indicate that when only property rights were at stake and particularly if there was some demonstrable urgency for public action necessary hearings could be postponed to follow provisional, even irreversible, government action. To many critics, substantive due process allowed judges to substitute their own views on political and social matters in the guise of constitutional interpretation.

Finally, the Court now attached more importance than the Goldberg Court had to Pearce Benton v. United States[68] the defendant was convicted of crimes involving a conspiracy to "fix" sporting contests and to transmit illegal bets.
